## 1. EXECUTIVE SUMMARY

### 1.1 INTRODUCTION

The institution has been established by Shree Agrawal Shiksha Samiti, Bharatpur, Rajasthan. Many of its members are running industries in Bharatpur and other parts of the state. They are always ready to devote time and money for the cause of upliftment of women education.
The institution was established in the year 2003 with arts and commerce faculty having view to educate girl students and to promote them for higher studies for a better career. With the pace of time the institution has started imparting education in science stream. As on date, the institution is providing research facility in the department of Geography. This year one student has been awarded with Ph.D. degree.
All academic, sports facilities are provided to students for their overall personality development. The institution also motivates its students to participate in some or the other outdoor game facility which develops reasoning, decision making power and discipline in them.
The institution recognizes the students bringing laurels to the institution. They are appreciated in functions organized in their honor. The Management committee provides scholarships to needy students.

During the orientation program arranged for newly admitted students, their hidden talent is searched. They are given facility looking to their interest. The institution is getting very good results. Students are becoming bold enough and confident to move out of city, state or country for participation in various sports competitions when they are sent by the institution or any organization.

To motivate the parents of students coming from rural back ground to send their wards out of city or state for participation in sports activities.
Removal of hesitation of participation in students and to prepare them mentally. Many a times, student mentors prepare and mentor them for facing the challenges of life.

### 1.3 CRITERIA WISE SUMMARY

## Curricular Aspects

The IQAC of the institution prepares Academic calendar showing the time and duration of all the activities to
be held in the session before the session starts. The academic calendar is uploaded on official website for all the stakeholders. Besides teaching, teachers appointed as in-charges of various committees also take care of the activity for which they are responsible. In this way each faculty member is well aware of all activities to be organized including the schedule for completion of the curriculum. The academic committee takes care of the completion and deliverance of the curriculum in time.
Two terminal exams are conducted every year and the performance of the students is indicative of their efforts as well as that of the faculty.
Faculty members are provided with OHP, maps, models, white and black boards, audio visual aids, smart class rooms and all other infrastructural facility required for effective teaching. By using and teaching with the help of such devices, students are exposed to latest techniques that are being used globally.
Internet facility is available in the library along with Delnet connection so that the faculty may optimally utilize the library facility.
Looking to the need of Computer Education, the institution has made provisions for exposure to its students to use software like MS Word, basic knowledge of Excel, preparation of Power point presentations etc.
The institution organizes curriculum and general information based guest lectures inviting experts from industry, university and social workers to the campus. During last five years the department of Geography organized guest lectures on topics related to global warming, delay of monsoon in Rajasthan etc by inviting senior faculties. Department of Political Science invited resource persons to deliver guest lectures related to constitution of India.
In the department of Home Science students learn stitching, tie \& dye technique, use of waste material, cooking, salad decorating activities. Students are exposed to entrepreneurship by learning preparation and preservation of achar, murabba, chutny etc. The institution provided a platform for selling their product by taking one stall in a Mela organized by an NGO.

## Teaching-learning and Evaluation

After the admission process is over, a feedback is obtained from the students regarding their hobbies, activities, field of interest etc. In the same feedback they are also asked how they came to know regarding this institution. All students are treated at par and given opportunity to participate in all activities. The institution never differentiates among the students in its activities on any basis. To keep the college environment cordial and for maintaining harmony among the students, the institution has introduced the concept of houses in the campus. All faculty members are engaged in some or the other activities. If needed, all the faculty members are ready to help each other which develops a good understanding among the staff members and working atmosphere in the institution.
The institution realizes that all students do not have the same capacity to grasp the subjects. Some students do excel in one subject or topic while others are good in other subjects or topics. To overcome such situation, extra classes or remedial classes are organized and personal attention is given.
On the basis of performance in terminal exams and class tests, teachers recommend the students who are weak or deviated from studies, to the career \& counseling cell.
Students passing out of this institution are well aware of the latest audio-visual techniques. The institute has realized that in PG classes, class room seminars are another very good mode for students to understand the topics. The students in groups of five prepare and present seminars which develops collaborative learning skill in them. The institution organizes group discussions, active research, quiz competition etc.
The institution has signed MoU with some industries where commerce students visit for industrial training. Students of Geography department are given survey practice and students of science group are send to Kevladev Ghana Project. The institution aims at developing self-confident learners with knowledge, skill and values to increase employability opportunity.

The institution organizes workshop in the campus for updating the staff members regarding use of new tools of communication and use of ICT.

## Research, Innovations and Extension

After the first cycle of accreditation, the institution has introduced research facility in the department of Geography. Presently 6 students are registered under the research guide Dr. Gambhir Singh. Two Ph. D. degree of this institution has been awarded recently.
The institution has developed the concept of active research in undergraduate classes. In this concept the students are given a general topic by the teacher and they are supposed to give or put their views on that topic. This activity is helping the institution in developing the research culture among the students.
The institution has invited eminent Professors from various departments. Through organizing guest lectures, students are motivated towards research.
The library of the institution has a conducive atmosphere which motivates its staff and students to pursue research. E-books, e-journals are available in the library for consultation by its stake holders. Students of postgraduation and faculty members freely use them. Internet facility is used by the PG students for preparing the notes and OHP slides, power point slides and videos.
The geography students go for socio-economic survey in villages. For settlement survey, instruments are also provided by the institution.
The institution organizes extension and outreach programs through NSS to promote a number of community development activities on the basis of local needs so that students may become socially responsible, moral values be developed in them. The institution has a tradition of organizing educational tours, camps like Yoga, health awareness, adult education, and rallies like anti-female feticide, anti-dowry, cleanliness awareness, plantation etc.
The institution believes that the participation of students in different social activities develops national character, improves their ability, enhances their decision taking power, expands their vision, make them responsible towards the society and ultimately a good citizen which is the primary objective of this institution. The institution also believes that if it is producing responsible girl students as citizens, then it is definitely securing the next generation as well.

## Infrastructure and Learning Resources

The institution is founded by Shree Agarwal Shiksha Samiti, Bharatpur. Whenever funds are required for development, funds are arranged by the trustees and donations by the industrialists of the Agarwal Samaj. When any construction work is proposed, the industrialists of this Agrawal Samaj donate whole heartedly for it. The Management Committee publishes names of donors along with their donation details in its annual progress report.
The institution has enough rooms and other infrastructural space to meet out the present requirements. Institute shall develop the infrastructure first before starting another course.
The infrastructure includes class rooms-18, fully automated library with reading room facility where two computers have been provided for students to access book availability, laboratories- home science-2, geography-1 and science subjects botany-1, chemistry-1, physics-1, zoology-1 and mathematics-1, smart class room -2, Principal office -1 , Principal Room -1, Staff room -1, Girls common room -1, First Aid Room -1, Store -1, Strong room -1 Language Lab (Under renovation), one ICT lab fitted with 25 computers, auditorium fitted with LCD projector and public address system. The institution has open air theatre to conduct cultural
activities, Courts of Basketball, Volleyball, Badminton, Kho-Kho, Kabaddi are available in the campus. The institution extends indoor facilities of chess, carom, table tennis and Judo. To meet out electricity emergency the institution has procured a Generator set.
The institution believes that in the overall development of the student sports play an important role. Students of this institution have excelled in various sports at State, National and International Levels. All students participate in extra-curricular activities representing their respective houses. Houses are allotted at the time of admission. The institution has developed yoga club, health check-up and awareness of health is a regular feature of the institution.
Three water tanks have been built up in the campus to regulate water supply, installed bore well fitted with submersible electric motor.
Faculty members submit their requirement and recommendations of new titles to be purchased to the librarian. Delnet pass word and ID is provided to the faculty members and they can access at home also.

## Student Support and Progression

The institution publishes its prospectus every year. The prospectus contains all details related to the institution and facilities available in the campus. The prospectus and website clearly show the admission process, courses, admission rules and regulations, discipline rules, attendance rules, fee structure, scholarships, co-curricular activities, program outcomes etc.
SC/ ST/ OBC/ SBC students are given scholarships by the State Government. The scholarship forms of such students are forwarded by the institution to the Government and disbursement of amount is directly in the account of student. Chief Ministerial Higher Education Scholarship was also distributed to students.
First Aid Room and doctor on call are available to meet out any emergency. Once a year general heath checkup of students is done in the campus.
The institution provides library facilities for NET/ SLET to students of PG classes. Students of UG course in commerce are prepared for Common Proficiency Test (for CA course).
In ICT lab, students use and learn the basics of computer. The institution is trying its best to develop the entrepreneurial skills among students. Students from the faculty of commerce are allotted industries to visit and understand the working culture. The institution is very much concerned with the overall development of its students. All students have been divided into four houses. All extracurricular, co-curricular activities are conducted through houses. The institution provides the sports kit for playing various games. Students participate in outdoor and indoor games and other competitions like mehandi, rangoli, quiz, essay, debate, group discussions, athletic activities, badminton, volleyball, basketball, kabaddi, kho-kho, chess, carom competition etc. At the end of the session, the institution conducts cultural program and prize distribution. The institution has its own mentoring system, through which students remain directly or indirectly in contact with the teachers. Wall magazine is a regular feature of this institution. Welfare measures taken for students are: scholarship by the management committee, the institution pays premium for group insurance of students, remedial classes for slow learners, delnet facility in campus to all students, book bank facility, educational tour, organization of free medical \& health checkup camp.

## Governance, Leadership and Management

The Academic calendar of activities is prepared by the IQAC members with the consultation of the Principal and conveners of other committees. The faculty members are entrusted duties and work for the session and they report the completion report to the Principal.

Leadership is required for the completion of all the work in time, implementation of policies rightly and to ensure that the plans are fulfilled in time. The top management, Principal and the faculty members of this institution are committed to the institution. Everybody is responsible for their duty. As a result of this work culture developed in the institution, it is becoming a premier institution in the city.
The involvement of leadership to ensure interaction with stakeholders reflects from the working of the institution and relations with them. The institution has very good relations with its stakeholders. When required, the institution invites the stakeholders to discuss the suggestions given by them.
The institution is determined for strengthening the quality of education. For this the management committee has no barriers of providing facilities. It holds meeting with the teaching and non-teaching staff members and seeks advice for improvement in the campus.
Major organizational changes in the institution was made on the recommendations of IQAC - the mentoring system consisting of chain involving all students and teachers, organization of house tournaments and decentralization of power which develop leadership and organizational quality in the students.
The institution maintains transparency in its policy, plans and process of implementation. The institution has clearly displayed its aims, objectives and mission in the campus.
The students of the institution are extensively involved in the social activities like social camps, rallies etc. The institution provides appraisal forms to each faculty member.
After discussing the requirements with conveners of all committees, annual budget is prepared. In case any expenditure goes beyond budgetary provisions, permission from the management committee is taken by the Principal.

## Institutional Values and Best Practices

The students and faculty go for plantation drive. Every year, a number of trees and plants are planted in the campus as well as in the village which the NSS unit of the institution takes care of. The students are encouraged to keep the campus clean and not to bring polythene bags in the campus. Instead, they are advised to bring cloth, paper or jute bags.
The classrooms are airy and well lighted and there is no requirement of tube lights in the day time. The students are advised and directed to switch off the fans and lights when not in use, thereby saving electricity. The institution celebrates Earth Hour and students are made aware of not using any electrical appliances during that hour so as to conserve energy.
To check pollution, waste papers and dead leaves are not allowed to be burned, bus facility is provided to reduce number of own vehicles, advice is given to say No to Crackers at Diwali festival.
To remove speaking hesitation, the IQAC gave the idea of seminar presentation for all the PG students.
The institution is using computers for keeping office record and term examination record. ICT workshop and seminars for students and faculty members are organized.
Students are given training on MS word package. Students act as members in almost all committees so that they may learn the practical aspect of working in group which helps them in developing decision making power.
Best Practices:
Imbibing a sense of responsibility in the students by the mentoring system.
This practice has been initiated with the aim to make the students feel responsible, to inculcate a habit of working in group, develop team spirit, to transform them into problem solving and cooperative individuals.
Impact of active research, wall magazine and class room seminars on overall development of students.
This practice has been initiated with the aim to inculcate values relevant to moral, social \& national needs, to make the students academically strong, versatile, self-confident individuals, to create target oriented aptitude in the students, and to develop a bond between all the students.

### 1.1.1

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

## Response:

The institution being an affiliated one follows the curriculum provided by the affiliating university. Before the beginning of a session, academic calendar is prepared by the faculty members and is finalized by the IQAC. All curricular and co-curricular activities are incorporated in it. The institution organizes an orientation program for the newly admitted students where they are explained about all activities to be organized in the campus. Therefore all students are aware of the academic schedule well in advance. At the start of the session the academic calendar is displayed to all students on the notice board and is also made available on official website. During class room teaching, teachers concerned explain topics to the students in detail before starting the chapter. The faculty members provide class notes to the students during their classes. Apart from class notes students can get copy of the presentation, OHP sheets. Students can avail reprographic facility in the library. During practical classes the material is provided by the institution under supervision of concerned teachers. Students maintain their practical record which is regularly checked by the teacher during practical classes. The head of the institution keeps in touch with the faculty members and obtains their feedback regarding completion of courses and assesses whether extra classes will be required. Since the institution holds internal examination twice a year, the syllabus to be covered as per the term exams is disclosed to the students at the start of the session. Most of the courses run by this institution are under annual examination scheme. From the current session 2023-24 the university has introduced semester system from part I of graduation courses.
The internal examinations are conducted on University examination pattern. The result of both the internal examinations are handed over to the students in parent teacher meeting. The students get a feel of the main university exam and realize its seriousness. Slow performers identified are counseled and given special attention by the teachers and the institution by organizing extra or remedial classes for them. The student's overall understanding regarding topics is measured through discussion in class room after completion of particular unit/ chapter in the class. The institution also notices the behavioral activity of the students admitted in the campus. Students' evaluation regarding behavior and over all development is observed by the teacher in-charges keeping the activities of students in their knowledge through student mentors. Regarding this process all students are well informed.

### 2.3 Teaching- Learning Process

### 2.3.1

Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

The institution is providing latest technology to its students so that they can learn by listening and viewing in practical. The institution is imparting education in the field of Home Science as a subject. Students learn stitching, knitting, cooking, achar, jam making, food preservation, washing etc during class work. Exhibition is organized to display the work done by the students. Every year three batches of 50 students each are sent to learn food processing and preservation at Indian Food Production and Training Institute, Rudayan-Aligarh. Faculty members use globe, maps, charts, models etc wherever it is possible. To extend participative learning the institution organizes group discussions, class room seminars are conducted so that students are involved in the learning process. In group discussion activity students are given general topics for discussion. Class room seminars are conducted by the teachers in class after completion of their topic. This activity helps the teachers in assessing the understanding of students about the subject. The institution is continuing wall magazine concept since 2011. Students are encouraged to actively participate in this activity. They bring different articles from magazines, prepare their own drawings, poems, short stories etc. All these activities develop their habit of reading \& writing, motivates creativity and innovative ideas. This brings out their hidden talent many a times. Students having practical subjects perform experiments during their classes, students having mathematics or accounts subjects are given problems to solve, home assignments are given to the students. For practical training, students from commerce stream visit industries in small groups during winter vacations. Faculty members are encouraged to prepare videos related to curriculum. These more than 100 videos are uploaded on institutional youtube channel. Students can access them any time or before their university exams. The institution has provided white boards, laptop, desktops, LCD projectors, overhead projectors, internet facility etc to faculty members, which are used by them during class room teaching. ## Response:

The schedule for internal examinations in the campus is well notified in the academic calendar declared at the start of the session. Two internal exams are organized every year. The process is explained to students during orientation program. These internal exams are conducted on university examination pattern. The internal examination process is clear to all students. After assessment, the answer sheets are handed over to the students. so that they can review answer-sheets before appearing for university final examination. If any student has any doubt about the replies given by her, she is free to contact the subject teacher and discuss her query. Faculty members explain their shortcoming in details so that they may not repeat such mistakes during university examinations. All such practices make the students secure better marks at university level. The marks awarded to students are not included in their final result declared by the university. Therefore much queries are not received and get resolved at class room level.
The university has its own redressal system. If any student is not satisfied with the marks awarded to her, she may apply to university for revaluation of her answer sheets. The university examination cell takes

### 6.4 Financial Management and Resource Mobilization

### 6.4.1

## Response:

The institution obtains the requirement of all departments. The management committee finalizes the list of requirements and accordingly procurement is completed. The excess funds are transferred to the management account. If needed the funds are transferred to the institution by the management committee. All infrastructural expenditure is made by the management committee. In the meeting of management committee they decide how much amount is to be spent on development of which of the infrastructure. Therefore the management committee diverts its fund in the institution where it is needed. The time table committee sees that there is optimum use of available infrastructure so that rooms are not vacant and students are engaged regularly in their classes.
The institution conducts internal and external audit of its accounts every year. A committee is appointed by the principal for the internal audit. Two senior faculty members and accountant are members of this committee. They submit their report to the Principal. External audit is carried out by the team of auditors. Chartered accountant firm conducts the annual audit and report is submitted to the President of the management committee.

1. Title:

Imbibing a sense of responsibility in the students by the mentoring system.

## 2. Goal:

This practice has been initiated with the aim: To make the students become responsible, problem solving and cooperative individuals.

## 3. The Context

To introduce the mechanism of mentoring was a challenging task. The management was of the view that this mechanism should be introduced with a feeling of acceptance in the campus; not by imposition. It was really very difficult to prepare the students in the campus for the new and unseen mentoring system. At first the students of undergraduate classes were mentally prepared to accept the immediate senior girls as their mentor. At the same time post graduate students were prepared mentally to accept the under graduate students as their younger sisters. Once the ground was prepared it became very easy to introduce the mechanism.

## 4. The Practice

In the first step, 5 postgraduate students were grouped under one teacher to whom they were supposed to report about the 10 undergraduate students who were grouped under them.

Once the students came to know to whom they were supposed to report, the mechanism was initiated. After a period of strife of about one week, students started accepting the mechanism. In this mechanism, these undergraduate students were to be helped in the campus by one postgraduate student. Such 5 postgraduate students were to report regarding such helpful activity to the teacher concerned. Post graduate students were told to deal with undergraduate students in a friendly manner so that undergraduate students would be able to discuss and share their problems or difficulties in the campus with them.

Information regarding some shy and economically weaker students was reported by postgraduate students. This mechanism also helped in identifying the students who could not perform well in term examinations and were worried about their career. Such students were called upon by the teachers and
were morally boosted and guided by them to attend remedial classes or extra classes. Teachers gave more attention to them in the class room studies.

## 5. Evidence of Success

Working of the campus became very smooth and actual problems of the students could be addressed by the faculty members and day to day problems of new and undergraduate students were resolved.

Small day to day working problems got sorted out at students' level. The student-in-charges also developed a feeling of responsibility towards their assignment. Success of the mechanism was observed by the lowering of dropout rate.

## 6. Problems Encountered and Resources Required

Some students were initially shy to talk about their weak financial conditions. Financial liability was taken care of by the management.

## 3. The Context

The IQAC of the institution has decided to make use of wall magazine, active research and class room seminars jointly as innovative practice in the campus. The faculty motivates students to participate in wall magazine. The students who display articles on the wall magazine are asked to give some information regarding that topic and post graduate students are supposed to give a small class room seminar presentation on that. In this way, the institution has designed an innovative practice for students, which helps in making the students aware of recent topics or activities taking place globally. They not only pick up the topic but also learn something about it, while presenting the details of the topic. Such presentation before classmates makes them self-confident.

## 4. The Practice

The wall magazine is maintained fortnightly in the campus. Students of all classes can participate in this actively. They submit their articles to the faculty in-charge at least one week before the display. Out of all the articles, the wall magazine committee decides which of the articles are to be displayed. After the article is displayed, the teacher in the class room asks the student to speak some words on the article and give more information to other students. Thereafter other students of that class are randomly asked to put their views and explain what they understand about the topic.
The post graduate students who give articles remain prepared for small class room seminar. After the presentation is over, other students are asked to put their views on that particular topic.
This activity encourages the students to obtain details from library and other sources which motivate them consult books and discuss the topics even outside the campus.
5. Evidence of Success

This activity has proved to be very beneficial for removing hesitation from the students. Those who give presentation gain self-confidence.
The overwhelming increase in the participation of students is indicative of its success. Every week the number of submitted articles is increasing. The committee remains watchful that new students be given preference to participate.
6. Problems Encountered and Resources Required

When the scheme was introduced, the committee felt great difficulty in motivating the students for active research part of this activity. Identified space for Wall Magazine board was required.
